Among many concerns with this document is the lack of consistency with previous planning decisions. EFDC should be aware that Area ONG.R5 was originally much larger in an earlier draft plan. It was pointed out that a large area of this land had been purchased by residents (including my husband and myself).

Following this we were instructed by EFDC to apply for change of use (from agricultural to horticultural - garden) which we did and were refused; on the grounds that this was 'detrimental' to Green Belt. We are awaiting an appeal decision.

The remainder of this area ONG R5 is ear- marked for 107 houses - this makes a nonsense of the change of use decision, a housing estate must also be 'detrimental' to Green Belt.

Our use as gardens protects the Green Belt and if compared to the proposed housing estate.

The area proposed is also on a very busy bend in the road which has very dangerous parking from parents waiting outside the school, resulting in driving past these vehicles without clear view of the road ahead. Increased traffic from the new houses will only exacerbate this problem. Also the is a high pressure gas pipe underneath the proposed area.
