The 1.7 hectare extra grazing land lays fallow at the moment. Previously arable land, the field is becoming harder to access with agricultural equipment due to low slung power lines. As a transition between the cereal crop and grazing the land has been sown to grass. The expansion of the grassland to new grazing is subject to the planning application. The farmstead allows access to the new grazing without the necessity of crossing the road. It is therefore in the interests of public health and safety to allow permission for the winter turnout to be located the farmstead side of the road. New winter turnout grazing to support the livery yard. The new grazing would remove the danger from crossing the road in the depths of winter. It will also now act as emergency grazing following the growth of mycotoxins in the current fields, which are all now shut. The mycotoxins seem to have arisen as a result of flooding.
