Since the proposal is only for the creation of two flats it will not be practical to provide the 1,100 litre red lidded general recycling bin or the 340 litre yellow lidded glass recycling bin appropriate for blocks of flat. Consequently the residents of the two flats will separate general waste from recycling waste and use the clear plastic sacks provided by the Council for recycling. The general waste is collected weekly on a Thursday, whilst recycling waste is every other Thursday.

Details of the pre-application advice received

The principle of development was considered to be in line with the National Planning Policy Framework and policies DBE1 and DBE3 of the adopted local plan in terms of increasing the housing stock.  
The officer recognised that there was a shortfall in the five year supply of housing and substantial weight should be given to maximising the use of urban sustainable locations, as such the proposal accords with policies CP1, CP3 and H3A of the local plan. However, the officer commented that in the emerging local plan the five year land supply is met through strategic sites and this site was not put forward and would not deliver the associated infrastructure, as such the officer considered the proposal did not accord with the emerging local plan.  
The proposed rear terrace balcony was considered likely to result in perceived overlooking of the rear gardens of properties fronting Smarts Lane and as such was considered to be contrary to policy BDE9 of the local plan.  
The officer advised that the internal layout of the proposed dwellings was considered to be acceptable.  
Given the proximity to the Epping Forest Special Area of Conservation the proposed development would be required to contribute to the management and monitoring of air quality in the SAC, with a financial contribution being secured through a Section 106 legal agreement in line with policy DM22 of the local plan.
