There is an issue with the obstruction and temporary closure of Public Rights of Way during development which makes parts of the Public Right of Way network un-safe to use and inaccessible, often for several years in the case of large developments. Alternative routes are either not provided or they are unsatisfactory being longer and may require moving along roads that may be busy and have no footway.

For this Plan to be considered sound, an extra paragraph A (vii) is suggested as follows: (vii) to ensure during the development phase, that ALL developments maintain access to and along public rights of ways (footpaths, bridleways & byways) or provide safe alternative routes, that are not substantially less convenient and that are accessible to all users of the categories of rights of way affected.
