#### **OUR PROPOSAL**

Area SR-0301 as listed in 'The Strategic Land Availability Assessment'.

The area we propose would reinforce the settlement plan providing a larger, more suitable area for the long-term future of Nazeing.

As well as providing much needed housing there would be opportunities to include a new wooded/nature area/park.

The area proposed is at present landlocked - bound on three sides by Pecks Hill, Hoe Lane and Palmers Grove - with the glasshouses of Tomworld on the fourth.

Access Points could be through Pecks Hill (NAZ R2 Area), Hoe Lane, Maplecroft, etc.

This area SR-0301 comes under Green Belt.
