There are significant problems with traffic in Nazeing, the proposal to develop existing sites implies that there will be further development of sites such as Hoe Lane, Nazeing, a country lane which is blighted by heavy traffic that travels through the centre of the village; locations such as these should be considered for housing which would ease the traffic issues. Any employment development should be located with easy access to traffic infrastructure. Nazeing employment should be developed on the Broxbourne side of the village, giving access to A10 and M25, so reducing additional traffic and congestion in the village.

5 of the 6 are PRIME GREEN BELT There does not appear to be any rational behind the selections. Nazeing is not a typical village. As well as being blighted by traffic it is also suffers from neglected old nurseries/greenhouse sites which are eye-sores and the development of which would be beneficial to the character of the village. There seems no logic in locating sites to the south and east of the village; most of the resulting travel would be through the centre towards Broxbourne so if there has to be development it should be located to the west of the village. It is difficult to identify the sites in the documentation but the land between Langley Green and Nursery Road would be ideal and would allow potential development of the

Fernbank Nursery site behind the shops - I believe these are SR-0298 and SR-0160 respectively. There is also a parcel of land which separates Paynes Lane from the centre of the village (SR-0583) which has been derelict for years, I believe it is an old nursery site and would be ideal with easy access to Broxbourne, development would have minimal impact on the village and also remove an eye-sore.
