Most of the proposed sites are on greenbelt land. 360 homes are far too many for the size of the village. It will put more pressure on services that are already under strain. At this present time it is very hard to get an appointment at the Doctors surgery in Theydon and most times have to drive into Epping to use the surgery there. I use the train with my children on a daily basis to go to work and school and even though we are one stop from the start of the line into London, by the time the train gets arrives at Loughton there aren't any available seats. If one train is taken out of service or they are delayed we don't even get a seat at Theydon. Large scale developments such as what are being proposed will add even more pressure to the services and this has a knock on effect throughout the district along the train line. Also Theydon Bois station is not very well served by the surrounding roads and the car park is already at full capacity by the time I get to the station Redacted. Theydon Bois is a lovely village within a rural village which has managed to retain its charm despite being only 30 minutes from London by train or car. Building a development of 50 plus houses on any one site will ruin the charm and character of the village. These areas will look like mini housing estates which are more suited to larger towns and not in keeping at all with the village.

8. An Interim Sustainability Appraisal has been commissioned to support the Draft Local Plan. We would welcome any comments you may have on this.

The interim appraisal is flawed as it does not support the wide dispersal of development in and around the small villages. An increase in population will put undue strain on the current services and infrastructure within the smaller villages. For example residents in Theydon Bois already have to rely on Epping and Loughton to use leisure facilities, doctors etc and this is not good for the environment as it will result in increased car journeys which is not good for the environment. The bus service is overpriced and virtually non-existent and this will be detrimental to the older residents.

9. Do you wish to comment on any other policies in the Draft Local Plan?

I think the other policies such as the design and infrastructure need to be improved. If we were told what would be put into place so that the village could cope with smaller expansions we could consider the proposals further. However as far as I can see there are no plans to do this.
