

I would like to put through a formal complaint regarding this process to object to the new build at Parklands.

I did forward you my objections but you told me that I had to fill in the very complicated form. The form is overly complex if you are not a planning officer. There are pages and pages of information to go through and I just wanted to make my particular points. I spent hours last night trying to come to grips with this form and I have completed the best that I can. This is designed to put people off from participating in their legal right to be part of the consultation process. I nearly did give up but I do feel strongly about the plan to take parklands out of the green belt.

It really is unrealistic for people to go through pages and pages of complicated information to make their point.

I feel that this is done to purposely put through changes without having any objections. I have spoken to other people who have felt exactly the same way.
