We support the Epping Forest Submission Version, specifically Policy P1 which allocates 11 sites in Epping for residential development, totalling 1,305 dwellings. The allocations are consistent with the Spatial Distribution Strategy outlined in Policy SP2.			
The allocations are based on appropriate and robust evidence, which has tested the sensitivity of land around Epping to accommodate new residential development.			
Policy P1 does not include Epping Sports Club and land off Bury Lane – a Green Belt site of some 9 ha – which was proposed for allocation in the Draft Local Plan, and we support the exclusion of this site.			
The evidence supporting the Submission Version of the Plan did not justify the allocation of this site. In particular, the work undertaken by Chris Blandford Associates (Landscape Character Assessment and Settlement Edge Landscape Sensitivity), the Green Belt Assessment report by LUC 2016 and the Site Selection Report by Arup 2017, did not support the allocation of this site for residential development.

We draw the Inspector's attention to the objection by Quadrant Town Planning submitted on behalf of some 50 residents (appended to this representation), which draws on these reports and indicates why the Bury Lane site is not suitable for residential development.		
Specifically, the Arup Stage 1 Review concluded that the Bury Lane site makes a strong contribution to the purposes of including land in the Green Belt. The landscape character of the site is defined by its openness. The retention of this site as Green Belt and its exclusion from Policy P1 is consistent with the NPPF.		
It is considered that the strategic allocation of land in south Epping for residential development, based on the evidence contained in the above reports is appropriate, particularly having regard to the Green Belt criteria contained in paragraph 80 of the NPPF.
