The plan is not consistent with national policy for the following reasons:

- The local council did not engage with any of the local community of the bordering borough (Havering)
- The plan that was put forward in 2016 did not include this proposal, this was only added four days before publishing
- The site is not suitable for development due to mains drainage not being efficient with the current houses in the area, adding significantly more will cause a major issue. Similarly, the village also has regular power cuts at the current time and would not be able to deal with more pressure on existing systems
- Flood issues are also a real concern due to the site being situated on a flood plane
- The local school cannot accommodate more pupils, many are already taught in a portacabin
- The road that would be used for access is an already dangerous one and access would make this worse
- The four areas of consideration for development in a green belt area have not been met. This site does not pass the greenbelt tests
