It seems that most of the proposed developments within the Plan for Theydon Bois are in the Green Belt. The scale of the developments proposed would alter the village beyond recognition and have an extremely damaging effect on the character of the locality. In addition, the transport routes from the Wake Arms Roundabout through Epping Forest (B172) and into Coppice Row simply aren't sufficient to take the additional

traffic - both numbers and size. I would imagine that to increase the size and suitability of this road would require expansion onto Epping Forest land - something that would be highly undesirable.

Having looked at the proposed developments for Theydon Bois, they seem highly inappropriate for the size of the village and would therefore require a complete overhaul of all the existing infrastructure including access to the Underground, where parking has now overflowed into surrounding country roads including Abridge Road. The bus service is also very poor.
