I do not believe a sufficient case has been made for, or justification of, the extent of proposed development in North Weald - specifically the area NWB.R3. Looked at within the district as a whole, the reduction in green belt land in the North weald area is grossly disproportionate to that proposed adjustment elsewhere in the district and, without convincing justification, wholly unfair to those living within the village.

More specifically, this proposed change to the green belt boundary I believe contradicts the stated aim in paragraph 2.150 that "The Local Plan seeks to protect and improve upon the quality of the natural environment in the District". The Flood Plain Meadow nature reserve located between NWB.R3 and Church Lane is a now well established and locally important reserve that contains important populations of flora and fauna that are now scarce in the wider agricultural landscape, both locally and regionally. The proposed reduction in the surrounding green belt will bring large scale housing development very close to this nature reserve and provide an insufficient buffer between this locally important nature reserve and the urban environment. The latter brings additional pressures from dog walkers and other leisure users which will impact greatly upon the nature reserve and threaten its future.

I believe that the proposed change to the green belt boundary in NWB.R3 needs to be scaled back significantly, particularly away from the location of the Church Lane Flood Plain nature reserve. Any resulting loss in housing development opportunity in North Weald should be met elsewhere in the district. The allocation for housing development (and concomitant reduction in green belt area) should be balanced more fairly across the district as a whole.
