5.24 This paragraph is misleading. The transport options in Loughton are not good. Firstly, there is only one bus route (No. 20) that serves the whole of the district. Quoting "over 20 different bus routes" is including those that aren't relevant to local residents. Other routes require you to take two buses to get from one part of Loughton e.g. Loughton station to The Broadway to the other. A bus route (No. 167) was recently curtailed and this has put increasing pressure on the No. 20 bus. An example the other day was that a No. 20 that I was on didn't stop at The Cottage Loaf PH even though I had rung the bell. When eventually I was able to get off the bus at the next stop I asked the driver why he had ignored the bell. He said that the bus was dangerously full and he couldn't risk a crush of more school getting on. This is potentially an accident about to happen or children being left in the dark as they can't board a bus that doesn't stop for them or is overcrowded.

The Central Line training often only go as far as Loughton, thus requiring a change for those continuing to Debden. Tube trains from Debden at the peak in the morning are standing room only and can reach dangerous overcrowding.

Additional housing will put more pressure on a woefully lacking transport infrastructure.
