I would like greater reassurance that there will be (a) sufficient school places and (b) sufficient parking to accommodate the significant increase in housing locally. Regarding parking, it is quite difficult living a 20 min walk from the tube station but not being able to park there - this means I have to walk, even when it is wet and dark, with my toddler to the station in the morning and evening. Other families locally struggle with getting to pick their children up on time from nursery, because they aren't able to park at the station. It seems very obvious that one of the major benefits of living in Epping is access to the central line and that the car park is always full - therefore it needs to be made multi-storey or additional space is needed, particularly if the town is expanding. This would also alleviate the pressure on surrounding residential streets, where cars park on the pavement and are often manoeuvring across the pavement, which makes it rather hazardous for pedestrians (e.g. walking in the dark in the rain with a buggy!) I am also hoping that my son can attend a local primary school in the next couple of years - it was one of the main reasons for living here. I would like to be reassured that there are sufficient school places if the town expands. I have also been unable to register myself or my son with a local NHS dentist, so hope access to NHS services - dentists and GPs - will also be improved.
