My wife and I moved to Ongar a year ago as we lived in South Woodford and wanted a family home which would service us for the rest of our life in an area which had good choices of schools and nurseries, nice quieter area with green space with not to much traffic and a local gym we can walk to. We have recently had a first baby and we have found out that the nursery called Zinc we are going to take him to that they are looking to build flats on there which will make the car park even smaller which it already has limited spaces and that all the schools in the area and there is a few, are all full up already with local parents that can not get there kids in to these schools. With your plans to build 700 new homes this will make it impossible to get our child in to a local school the time that they are built. Also we have had to use the doctors more than usual lately because of our baby and it is very hard to get an appointment within a few days and even to get through to them and this is new surgery so once again this is going to be even more over subscribed. As mentioned it was important to us to have a local gym which we all use regular and you are planning in SR0848 to remove the gym to build on and I have also learnt that you are also planning to do this at the Epping Gym which I also use each week and to build a new gym in the centre of Epping Forest somewhere. I can not believe this has even got to this stage as health for people is at such an importance for government and individuals that you should be encouraging more leisure centres. Traffic within Epping Forest is so high all over and to get to town to town takes such a long time and this was the case when we leaved in South Woodford and by moving to Ongar we thought this wouldn't be the case as I can get to my work in Buckhurst Hill the same time than what it took when in South Woodford. Within Ongar tariff is a problem already as it is a through road for the A414, M11,M25 and getting through the high road in rush hour can take 15 minutes and so does coming up the A414 from Harlow to the Four Wantz where we leave it goes back past the Vogan indian restaurant and takes again 15 mins. With these 700 homes and the other homes which have already been agreed with more than 500 homes including the Fyfield site you are looking to build on and very close to the Four Wantz this is going to be a no go area and you need to look at not build as many homes within this area. Also the public transport is nearly non excitant. No trains and a bus from Ongar that doesn't run often takes 45 minutes to get to Epping. You have stated that 40% of the homes will be key workers / affordable homes so the majority of these people will rely on public transport and with no plans to expand Epping station car park then how are we all going to get around without using our cars which will make more traffic
