Here are my very simply views about the 950 houses that it was proposed and recently agreed to be built in the Brook Road area:

If they didn't want this they would NOT have continuously voted for councillors who have no other intention than building the new houses and knocking down the Sports Centre.

I am a democrat so I just ask that that you, as a councillor and, if you can pass this onto other councillors, consider the following because I have no wish to change what the majority of the people of Epping CLEARLY want:

If you are going to build 950 (or 1300, whatever) new homes in a small town like Epping, PLEASE make sure that there are enough roads, school (infant, junior and secondary (or even grammar)) for all the new people that will arrive here. I hope you have a a water tight plan for where the new buildings are going to be built. I request, please don't start building the new houses until the hospital, school and road infrastructure has been put into place.
