Waltham Abbey Community Association agree with this, but have concerns about the infrastructure. The plans for roads, policing, hospitals, schools, drs, nurseries and elderly care has not been released yet, not even in draft form. We feel that even with promises on this that the basic infrastructure wont materialise once the housing has been built. Extending the existing shopping areas may not work as existing shops and businesses struggle to compete with out of town retailers and online businesses. Parking and road congestion continue to be a huge problem in our area especially if there are problems on the M11 or M25.

Waltham Abbey Community Association have grave concerns about the development of the land that Waltham Abbey Community Centre Saxon Way stands on. Waltham Abbey Community Association is a charity who have successfully run Waltham Abbey Community Centre since 1949. The Community Centre is a much used and successfully run local facility. We have over 500 users of the centre every week, numerous volunteers,6 paid employees, not to mention an over subscribed preschool, a Day Centre for the elderly and socially isolated vulnerable residents of Waltham Abbey. We are also the hub of many local group activities and businesses. We are also used by Epping Forest District Council as a polling station. We have a solid 15 year lease on the building and yet no one has consulted us at all. Simply being on the plan is affecting our business because people are presuming and spreading gossip that we are being knocked down. Central to the draft local plan is to "Conserve community buildings and assets" This plan for Waltham Abbey Community Centre goes against the ideals set out in the local plan, which also states that it will " work to protect and make best use of existing employment sites" and "enhance the quality of life for local people" This proposal will take away a much used asset to the local community with no plans to replace it or consider its existing use. This community building which is so central and well used must be preserved. Losing a community building like this would result in the loss of a Day Centre, a preschool, many local businesses and social groups and a much needed hub of the community. There is no other Community Centre in the town, nor are there any other Day

Waltham Abbey Community Association disagrees with this because as yet no plan for infrastructure has been released and cannot in any way be guaranteed by the council. Our schools are full, and if the plans go ahead

to develop on Community Centre land a nursery/preschool will be lost. Our hospital is graded inadequate and cannot cope with the existing population. The districts roads are busy and dangerous rural roads that come to a standstill and gridlock towns as soon as there is a problem on the M11 or M25. Waltham Abbey Community Association believes the infrastructure should be in place or at the very least guaranteed in some way BEFORE the housing plan is put in place. However the draft plan for infrastructure hasn't even been released yet.

Waltham Abbey Community Association believe this plan is only sustainable if the infrastructure is sound. As no plan for infrastructure has been released yet, we cannot know if it will be sustainable. At the present time with the infrastructure we have now, the plan wont be sustainable. Our bus services are being cut, not improved, our roads are inadequate and poorly maintained. Our area has and does suffer from flooding. Our water and sewage mains are Victorian and already struggle to cope.
