It has taken me 40 minutes to get from the 4 wantz round about to the end of the high road by the a128 before. How would the roads cope with more. Are on the road. Further to this there is no active police station in or near Ongar, recently there have been violent attacks and an increase in burglaries, an influx of people would exaserbate this issue. As well as this schools, particularly primary schools are at capacity where would the children moving into the area go? In Ongar, we now only have 1 doctors surgery, they are working at capacity with waits for appointments that are days/weeks away. How would they cope with the influx of people? Additionally if you don't drive transport links in and around Ongar are dire... there are 2 buses into Chelmsford on a Saturday. Transport links are not great and again this is another reason the proposed plans are flawed. Not only this, Ongar and most of Epping forest district is famous for its green spaces, its small market towns and villages, the proposed plan will not only put huge strains on the infrastructure of these communities but eradicate the very nature of them! I think it would be a crime if these proposed plans go ahead!
