Nothing seems to have been said about schools, doctors, policing, hospitals, nurseries and elderly care, roads, transport links and parking. Also measures put in to avoid flooding. With the Meridian Park development in Waltham Abbey these were promised but never materialised. Its vital to help the local shops against out of town retail parks and also vital to protect the Green Belt.

While I appreciate the need for extra housing within Waltham Abbey and agree with some of the sites proposed, I am amazed that the community centre at Saxon Way has been chosen for 50+ houses to be built on it. This community centre is the only one in Waltham Abbey and in the draft local plan and emphasised by councillors it has been stated that community and leisure facilities would be protected. Waltham Abbey community centre is used by over 500 people each week. It has a day centre for vulnerable, isolated, elderly people (3 days per week), a preschool (5 days a week), a large number of group activities held weekly. It is used by businesses, local people for functions and also employs several people. This proposal would take away a much used and needed facility of the local community. Finally Waltham Abbey Community Centre still has 17 years of lease left. Any redevelopment must ensure continuity of use for the community centre. Abbey already has large housing estates and we do not need or have room for any more large developments. The Crooked Mile proposal for 400+ houses is too large. I understand that Waltham Abbey fire station is equipped to respond to river accidents and incidents. Also its close proximity to the M25 enables it to respond quickly to any motorway incidents. To close the fire station would be a retrograde step and could put lives at risk. If Waltham Abbey Fire Station is regarded as a prime housing site I would be OK with this as long as it is relocated in this area. As a Waltham Abbey resident for nearly 40 years and having gone to see the draft proposals and attended local meetings about it and spoken with WATC councillors, I feel that our councillors have put forward a lot of fair and considered changes to the draft plan which should be seriously taken into

No infrastructure deliver plan has been published yet which does not fill me with confidence. In Waltham Abbey we cannot cope with the existing population. The schools are full, the hospital is in special measures, or roads cannot cope (any incident on M25 or M11 brings Waltham Abbey to a stand still). Transport Links are poor. Flooding could certainly be a problem. Surely infrastructure should be considered in conjunction with increased housing or do we get the same as happened at the Meridian Park development in Waltham Abbey where much that was promised never materialised?

Paramount to sustainability is adequate infrastructure as nothing has been published yet, how can we comment? Nearly every aspect of infrastructure in Waltham Abbey is near breaking point.
