These are vague promises. There is no evidence in current plans that they are likely to come to fruition. We cannot let all these houses be built first without new roads, schools, doctors surgeries and a new hospital being built first. You cannot get into any local schools at present or see a GP. Without a 6 week wait, they are so busy, they try and diagnose your condition over the phone and often leave a prescription out for you without seeing you. The roads are a nightmare, **...Redacted...** (Brook Road) is chaos, daily, several times a day and in the evening, you cannot park because of commuters taking our spaces. There are abusive people shouting and swearing as they cannot pass each other as it is so busy, it has become an absolute hellish nightmare to live on my road. We have lived here for 23 years and watched it get worse and worse. We love our house, have brought our four children up here, one of my children was born in our house, we have loved it, but it has become increasingly stressful, noisy, busy, drivers being rude and aggressive to one another and to us residents, the roads around Epping and all the local areas are a nightmare, so how do you think building more houses with more people and cars, is going to help alleviate the problem we already have. Also the pot holes in and around Epping, especially on crossing road are impossible to avoid, the holes keep being refilled but as the next cold spell comes, they reappear again, getting bigger each time, they damage your tyres.

New houses - noise, mess, more people, more cars. Roads/traffic - pot holes, parking, noise. Schools, hospitals, doctors being full now already. Pollution - allergies, illness, asthma. Wildlife - being disturbed. Trees being cut down. Brook filled in. Tube station - too many commuters parking, too much capacity now. No green spaces/belt - left to enjoy - walking in or seeing. Houses - looking at 'new houses' instead of old traditional style houses.
