There seems to be a disproportionate amount of housing in Epping in proposed sites compared to it's existing population - this seems an unfair percentage. It is similar for North Weald. This amount of new housing and the impact on facilities/roads/schools etc will be huge. I am particularly concerned about the total number of houses for Ongar -600, Coopersale-50, Epping - 1640, North Weald - 1580 Theydon Bois - 360 and Thornwood -130, totalling 4360 and the subsequent traffic this will bring. Living in Fiddles Hamlet I am experiencing numerous accidents at the junction (a list can be provided) as this area and the smaller rural roads linking the villages above are used as 'rat runs'. Traffic calming/new enforcements for speed etc. need to be implemented not just on the areas where the new houses ar ebeing built but also on the surrounding linking roads. Also the areas in Ivy Chimneys (358 homes) Brook Road (244 Homes) and Steward Green Rd (305 homes) all converge to
