# Survey Response:

Please explain your choice in Question 1:

I strongly disagree with this. The 244 homes that are planned off of Brook Road and the 334 homes south of lvy Chimneys Road, which are the two proposed development areas that are of most relevance to my local catchment area, have not considered the impact on the infrastructure. Brook Road as it is, is a rat run and I strongly believe that until an unfortunate event occurring when someone or a member of someone's family is either seriously or critically injured, then the local council will continue to turn a blind eye to the dangerous road conditions that are present currently. The single width road currently is grid locked during peak times (School and Work) and the traffic calming efforts are not sufficient. There have been numerous incidents since I have moved into the property since the 24/08/16 that I have seen vehicles collide with parked cars or collide with them as they pass each other. The parking in the area isn't designed for local residents and does nothing to aid them with parking outside of their homes as permit parking is not in place for residents, due to the local council not sanctioning it previously. Heavier works traffic that would be obviously necessary in order to deliver the housing projects would create further gridlock and pose an ever increasing significant risk to local residents and their families. The roads in this area are also in a poor state of repair the road formation has dropped all through Brook Road, because the natural fall of the land. Speaking to local residents its seems to be the norm in Epping for the roads to be potholed and in a poor state of repair. Whereas in neighbouring Theydon Bois the local roads are in an excellent state of ....Redacted.... Due to this the road is forever deteriorating. The crossways road, I have physically seen the surface water drainage run as it approaches the main outfall into the stream via the culvert blown out due to insufficient design capacity. Installing new roads and increasing further surface flow will put more pressure on this natural outfall stream and poses more risk to the homes already established along Brook Road. Emergency vehicles can never navigate through Brook road with ease and being so close to local schools are being a key arterial route, this is a massive oversight when considering public safety. From local neighbours I also understand that the catchment areas for the schools are getting smaller and smaller. There is no plans so I'm told for new schools or public surgeries so how is this new proposal sustainable. My main concerns imminently are the infrastructure, a local surgery and parking arrangements as these are most relevant to my current life
