The roads are extremely narrow and there is often gridlock on the back roads. Emergency vehicles and waste collection vechiles can often not gain access. It is also at the bottom of a hill and subject to flash flooding. This will clearly exhuberate the current problems, the infrastructure is not designed for to take this additional strain. Parking is extremely difficult and the safety of the children at Ivy Chimmenys also needs far greater conideration.
