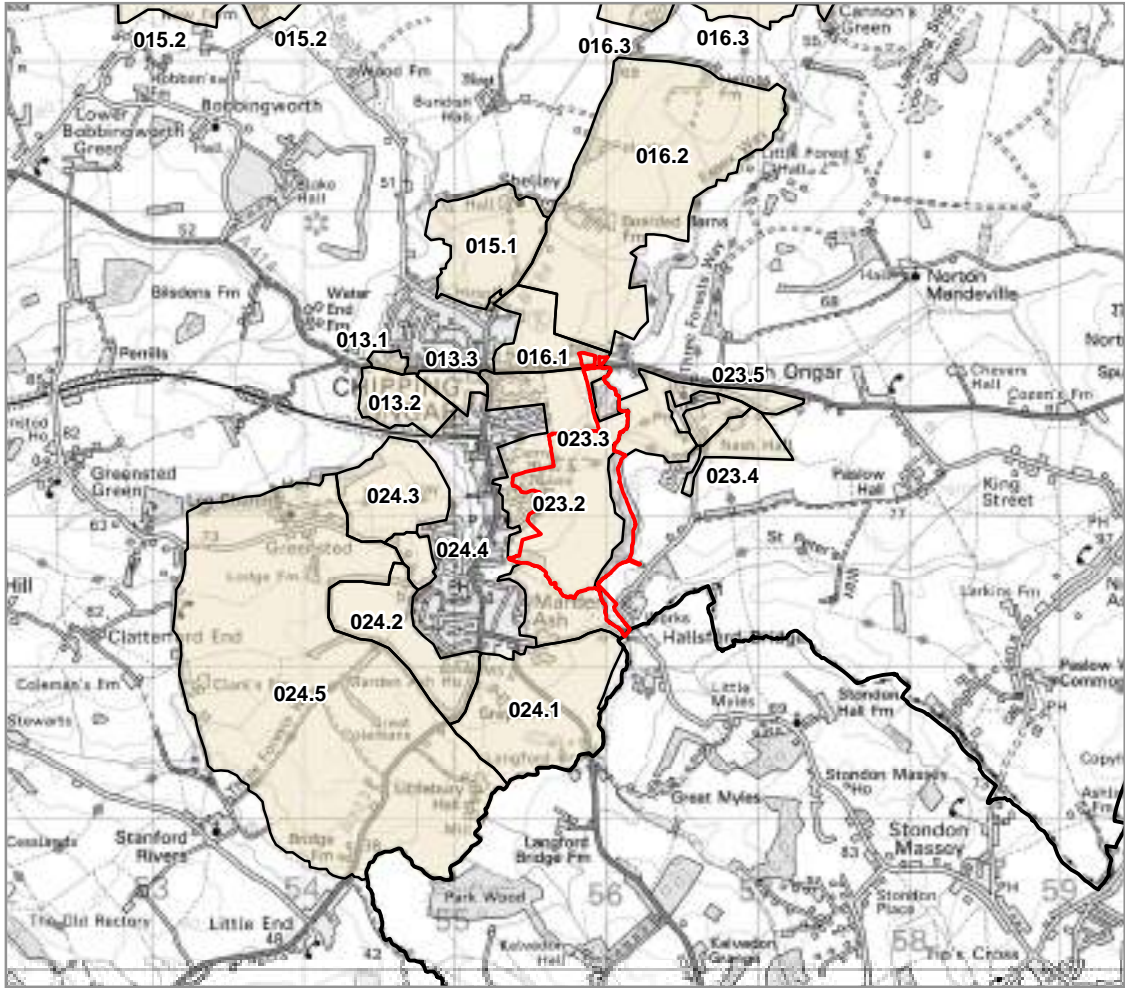

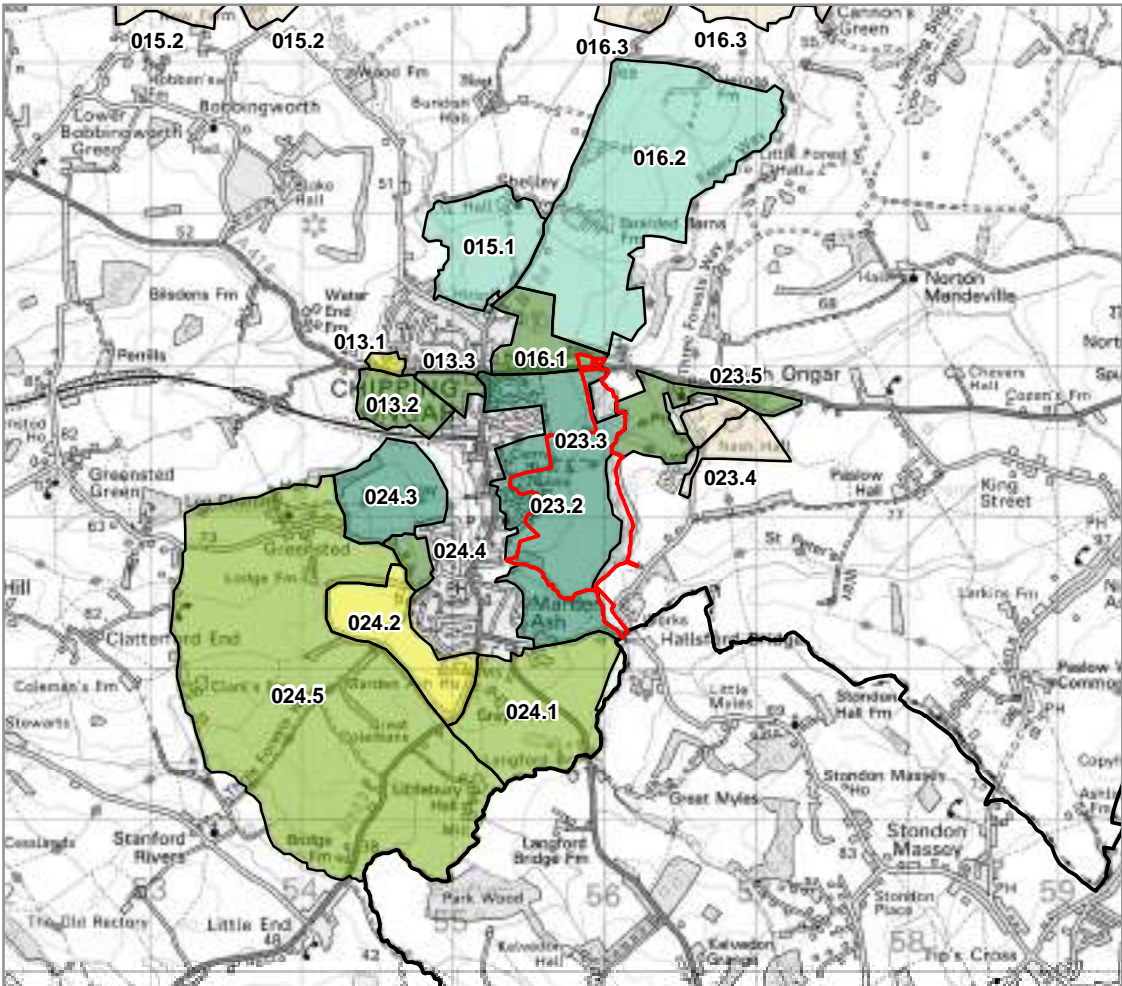
Purpose 1 Map (To check the unrestricted sprawl of large built-up areas)



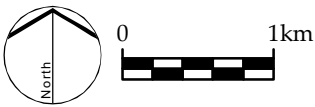

to National Green Belt Purposes

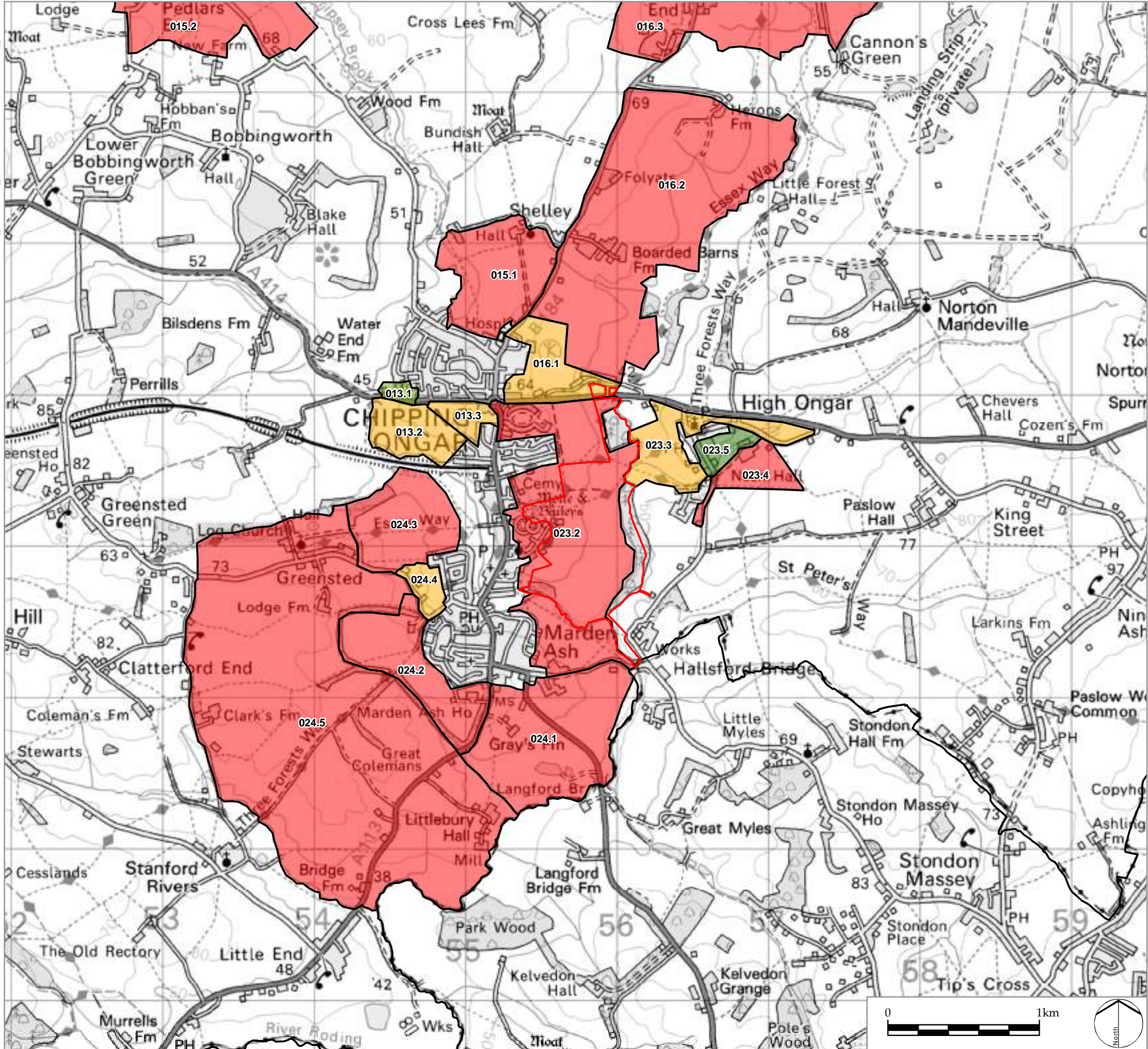

(purposes 1, 2, 3 and 4)

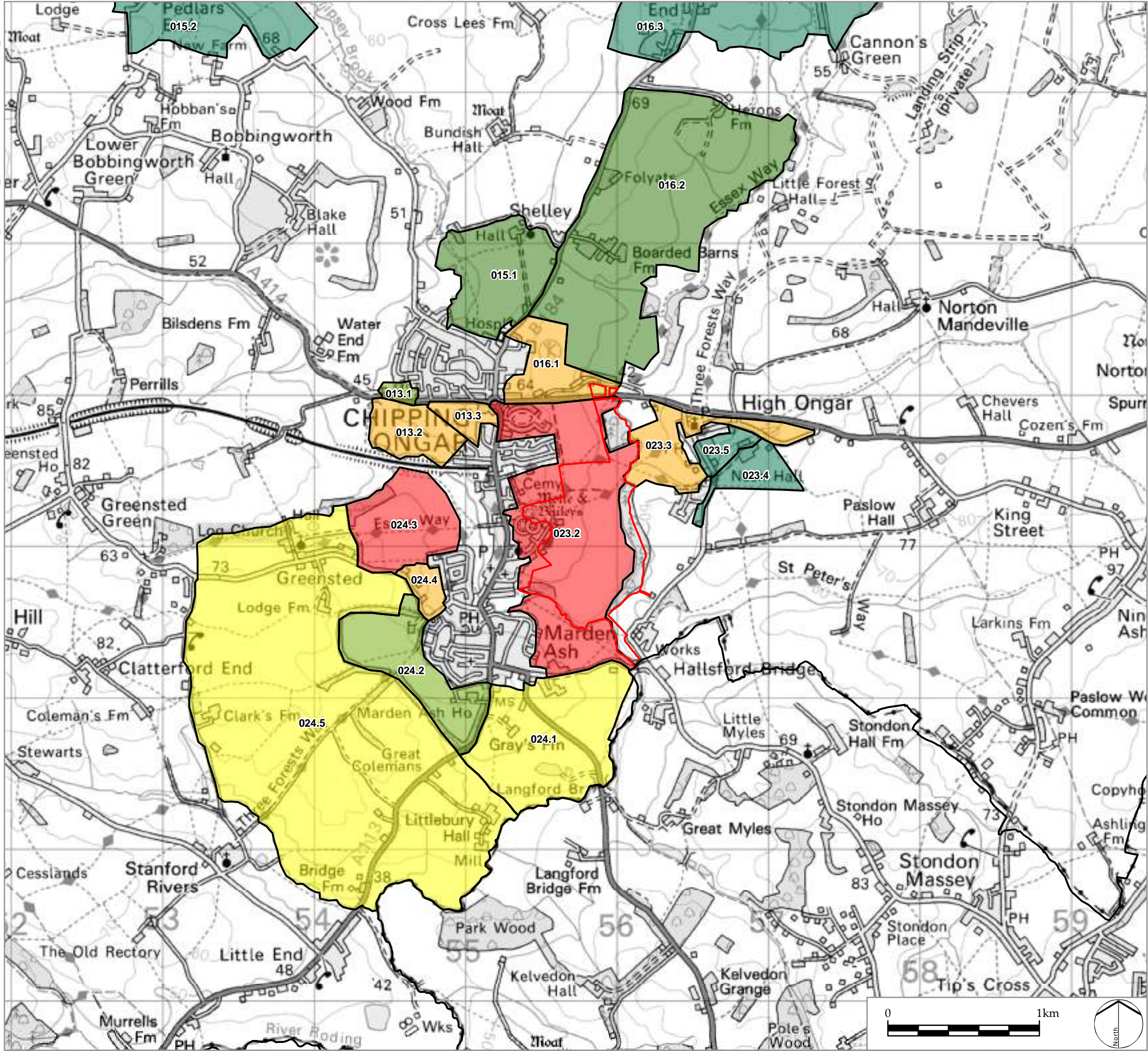

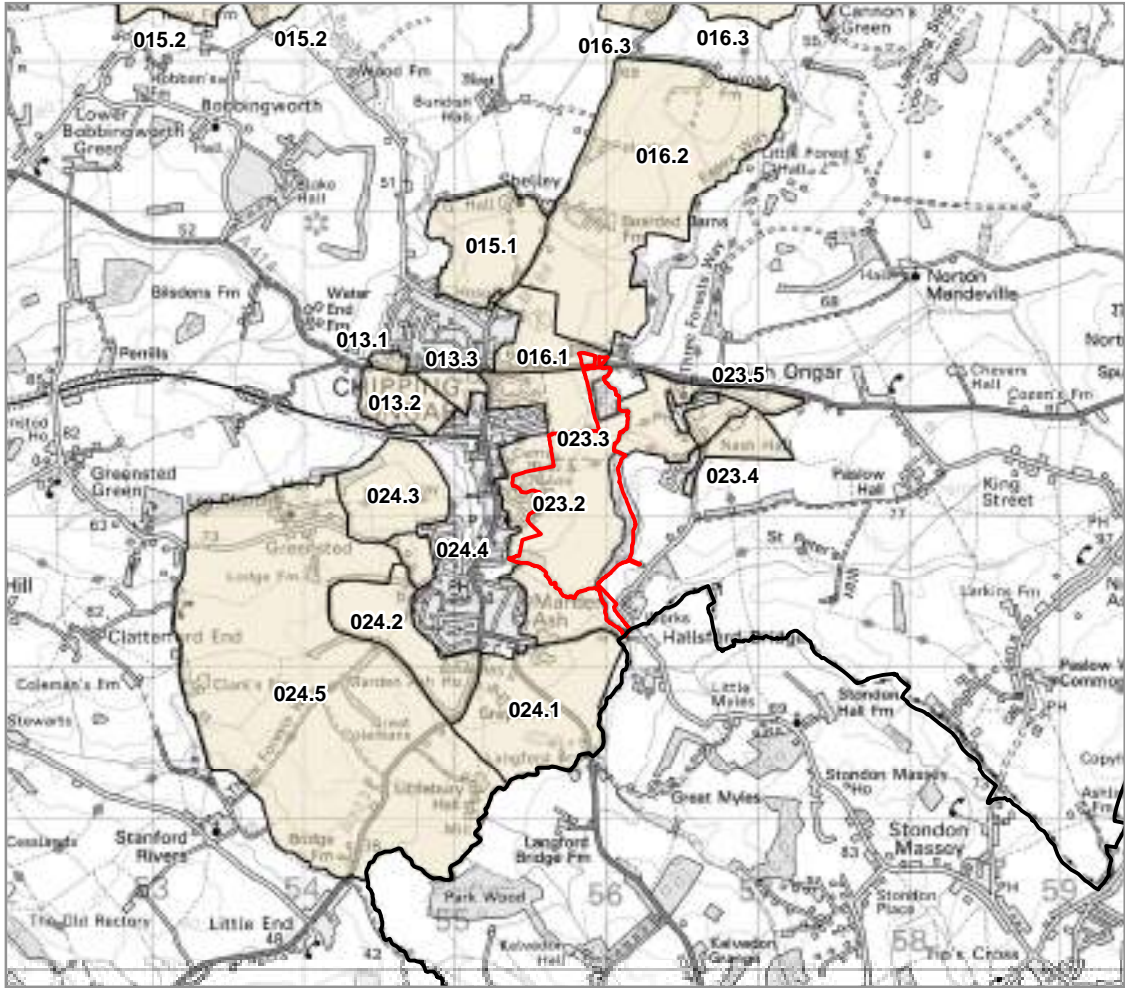

(excluding purpose 3)

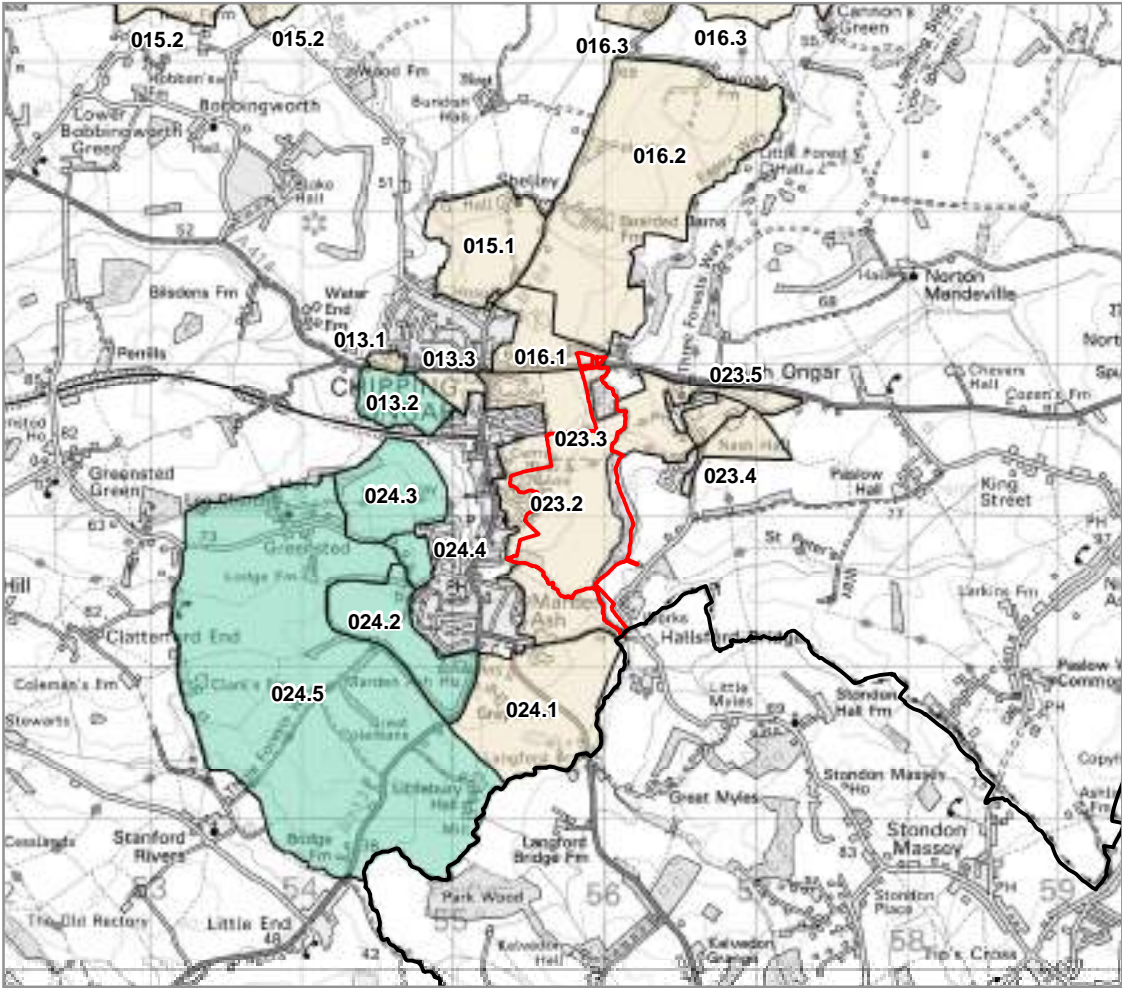

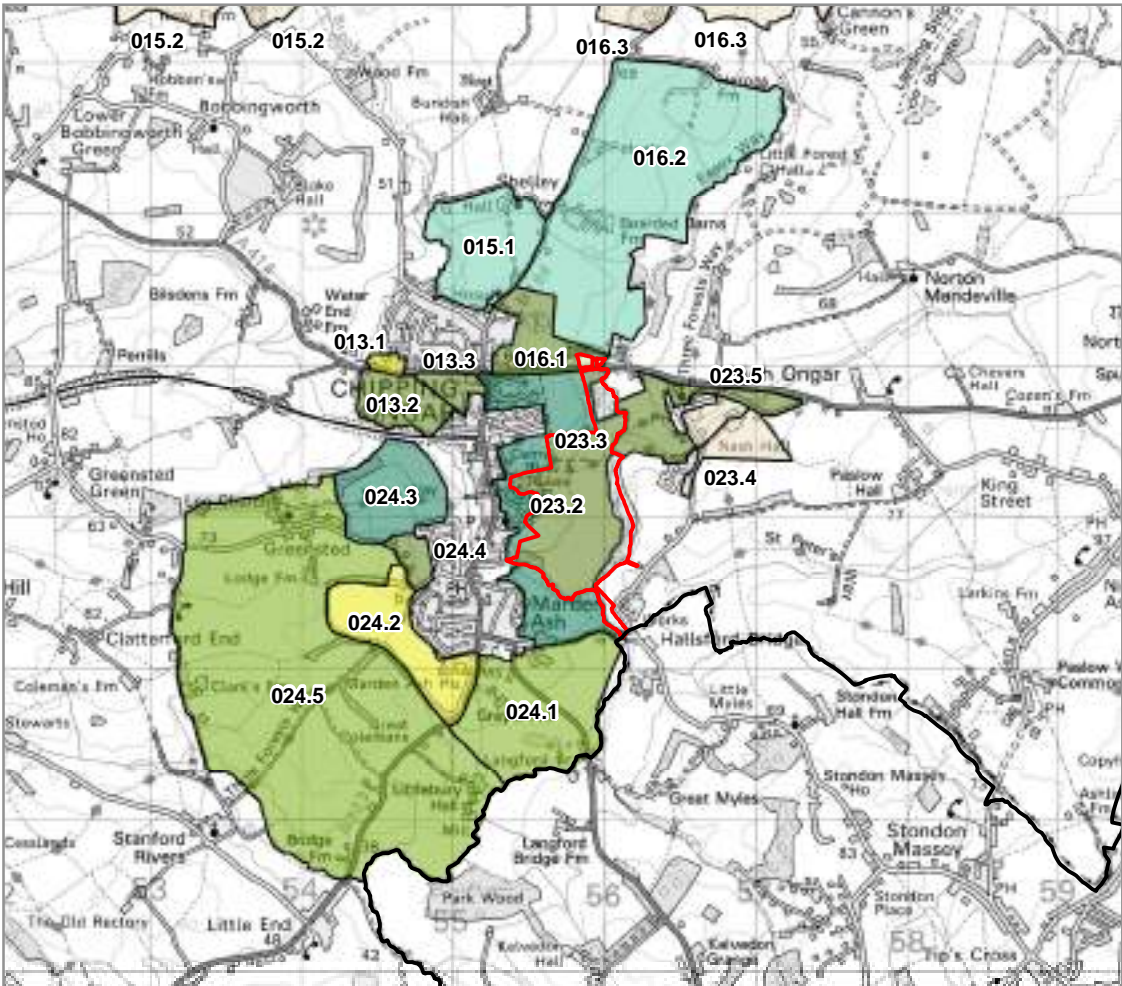

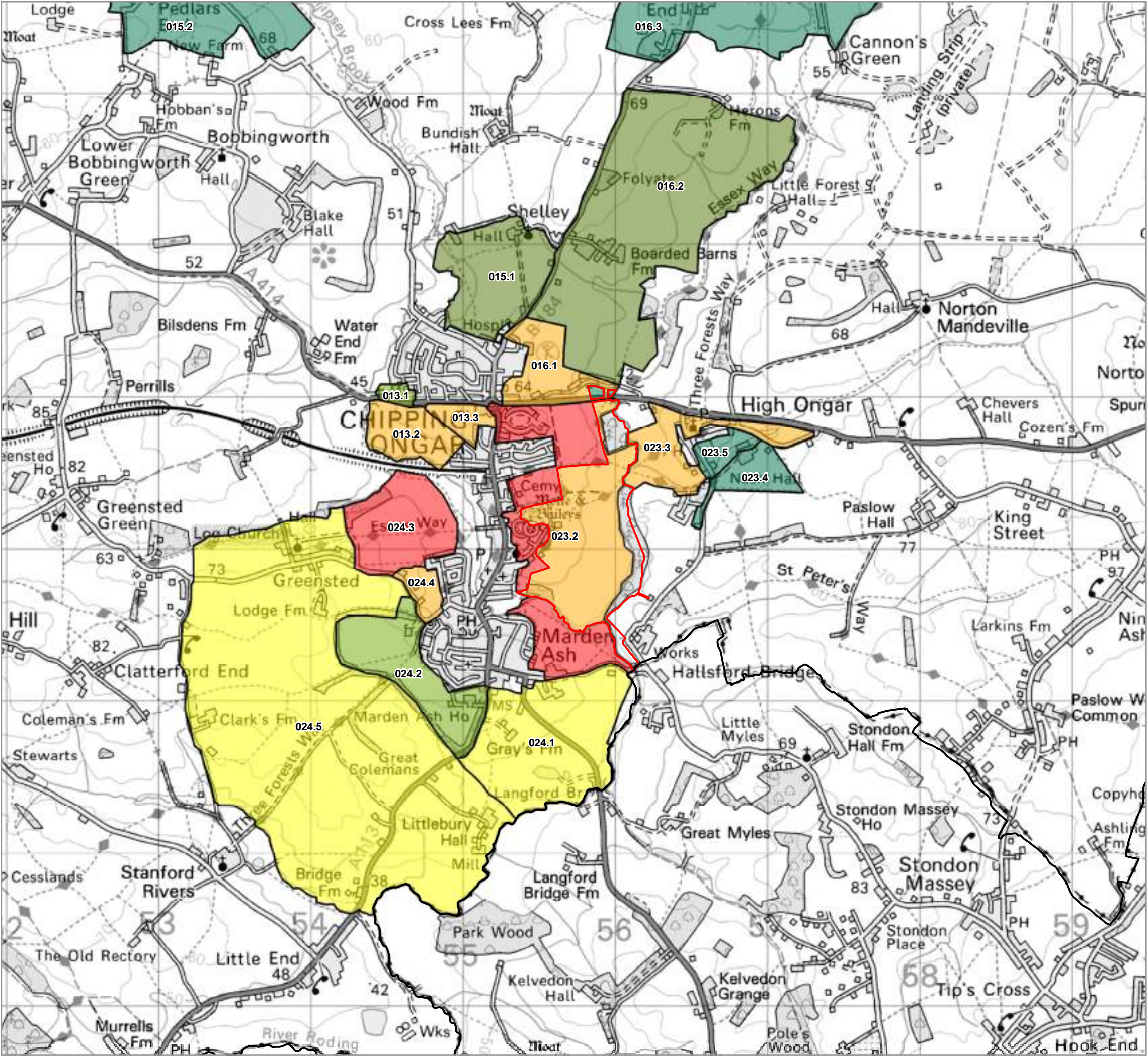

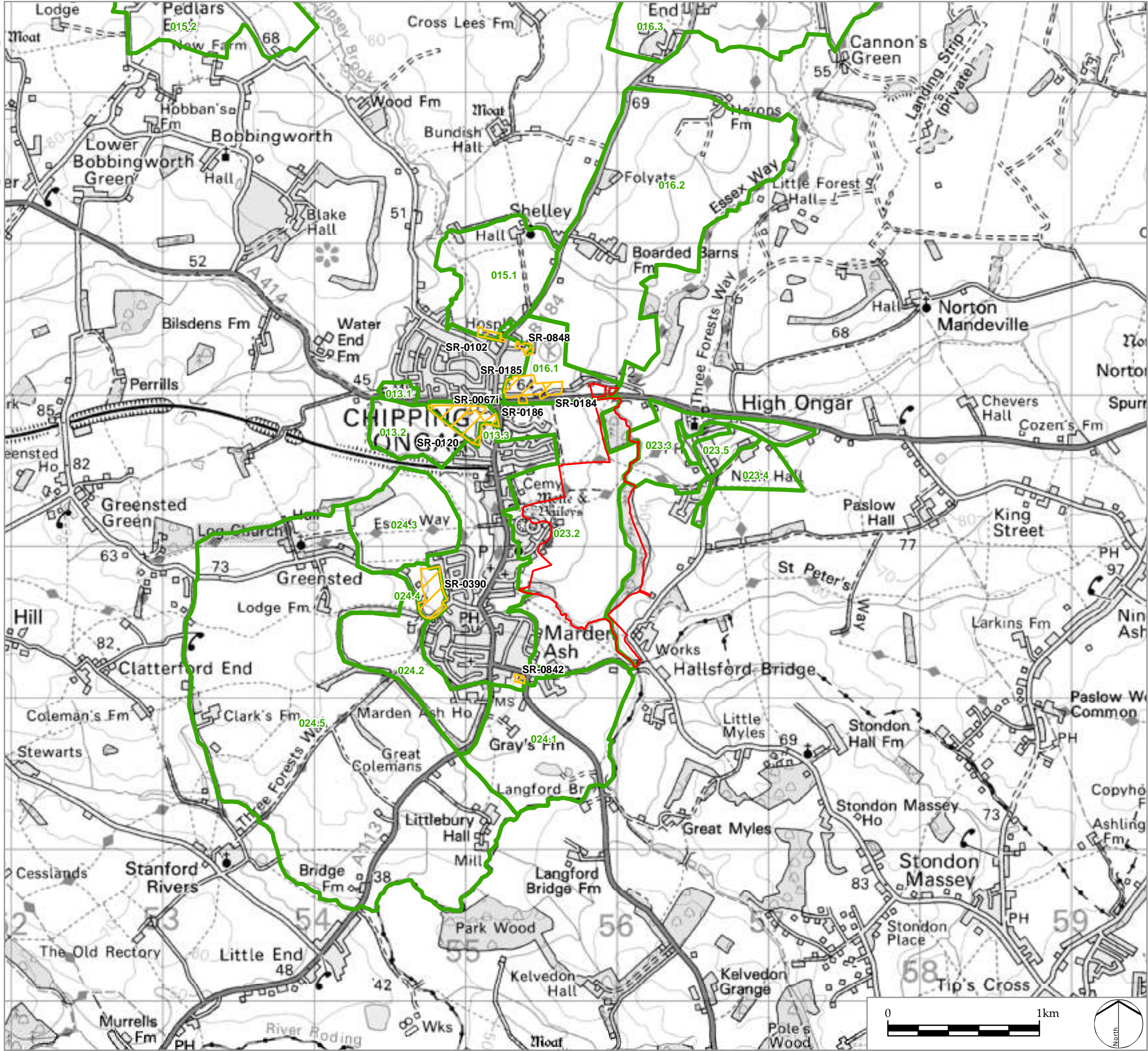

Topography

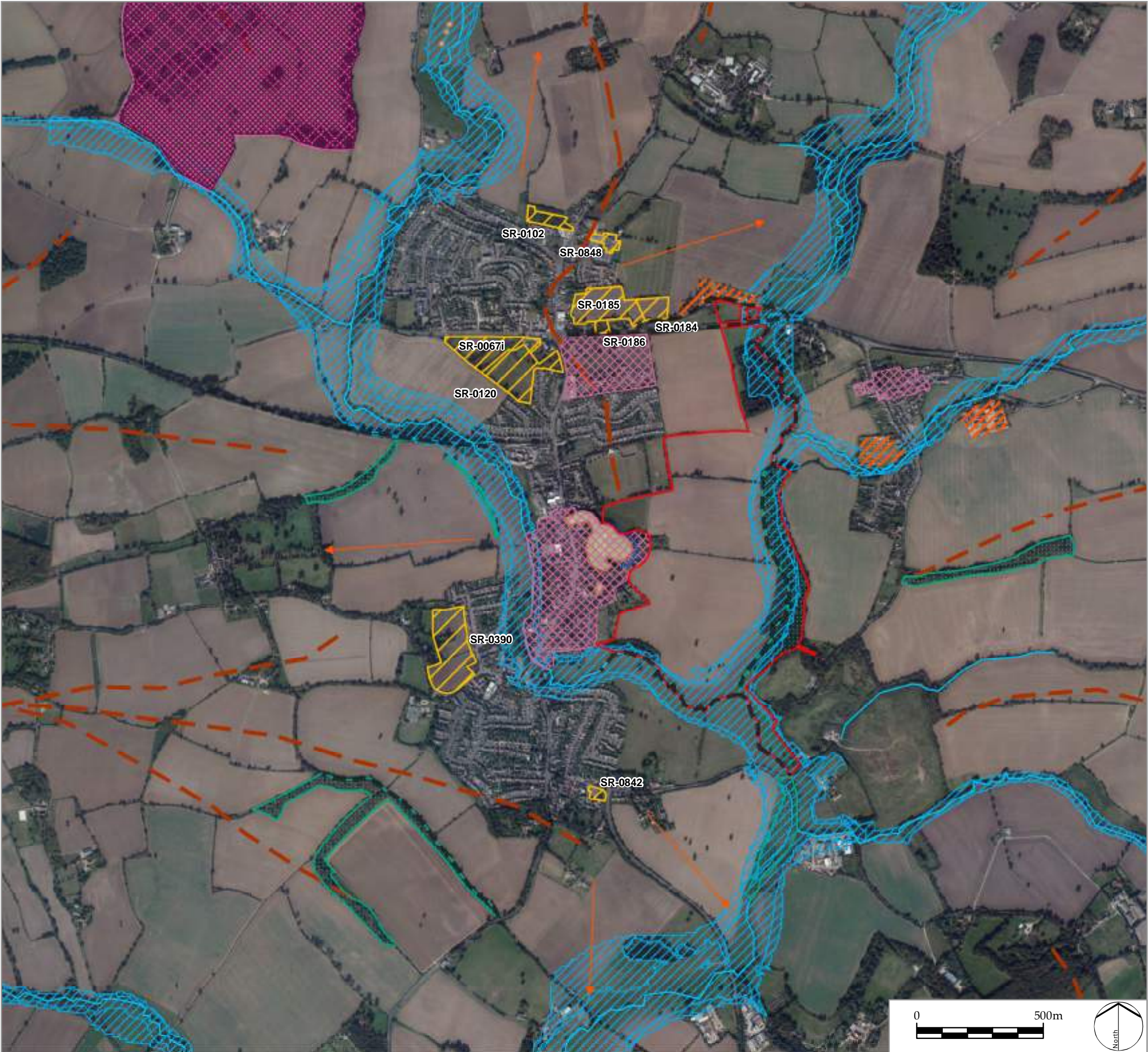

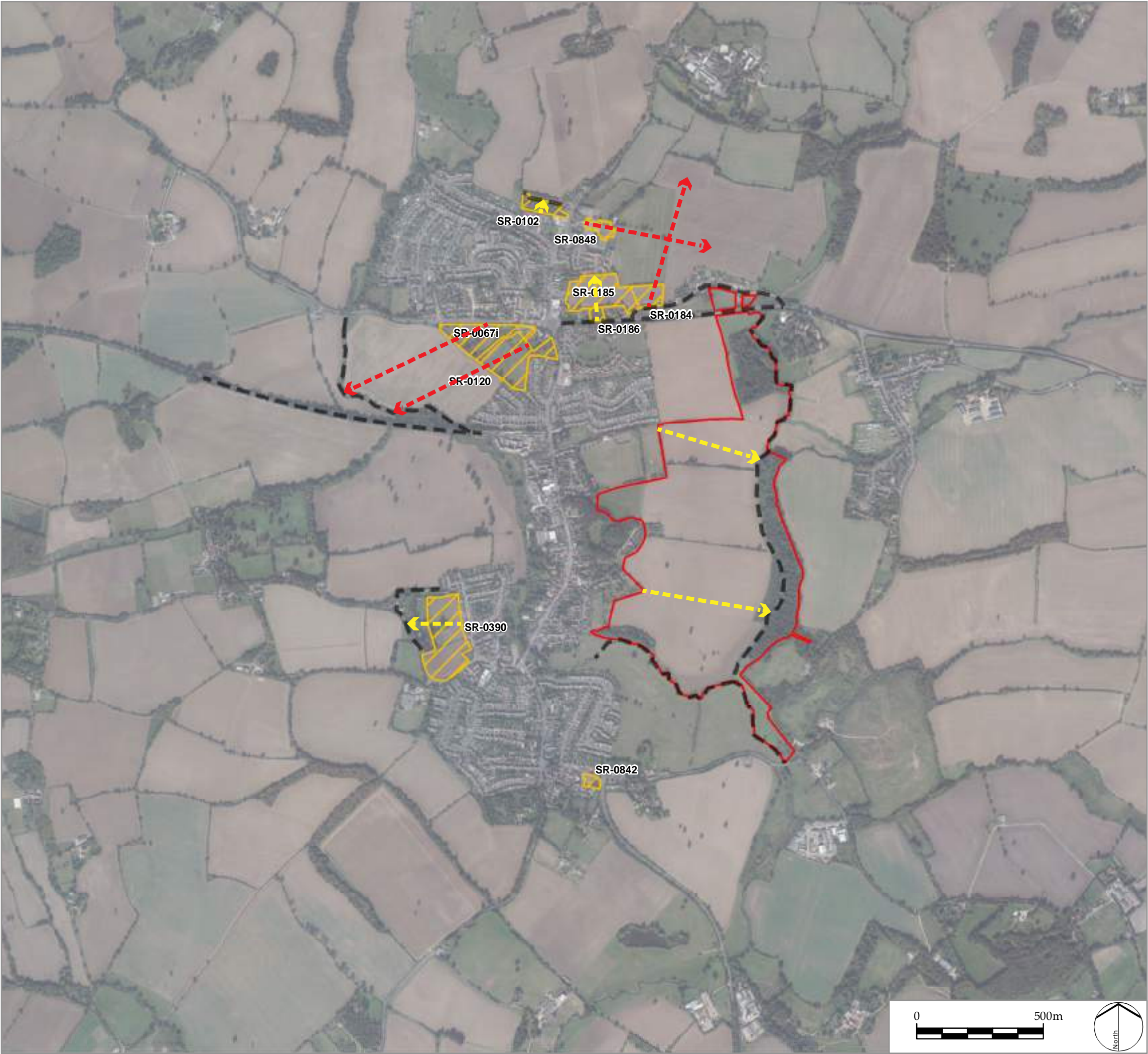
