I strongly disagree with the proposal to build over 200 homes on the Limes Farm Estate which is referred to on page 155 as the Limes Estate! I feel that this will be a detriment rather than a benefit to the existing community. This is also against the Chiqwell Parish Council's Neighbourhood Plan which states " Such a proposal will not provide for the proper planning of the area and will only likely lead to further social problems and a severe degradation of the local environment for the local community. For those reasons, this policy resists such a proposal with the hope that the District Council abandons its plans." I oppose the building of over 200 houses because no detail has been given as to how the infrastructure will be improved to accommodate a possible 200 families. Presumably the primary school on the Limes Farm Estate will need to be expanded or a new school built but this is not mentioned. The nearest secondary school West Hatch is already expanding next year to cope with existing demand therefore additional families would add to this pressure. There is also no mention on the impact that a possible increase in cars would have on the highways network (if every household were to have a car this would be over 200 cars). Would there be sufficient parking? Would access be from Manor Road or from Fencepiece Road? There is also no detail given as to whether there would be new GP surgeries, dental practices etc to cope with demand. I appreciate there is a need for social housing but the building of over 200 homes would have a detrimental effect and put a strain on the community. It is not just about the loss of the green spaces which are used and appreciated by the community but about making sure that there is proper planning and consideration for the existing residents of the Limes Farm
