This plan needs to ensure economic progress, but not at the expense of social and environmental progress (this is stated within your plan). However, the proposal of 21 properties on the Kingsmead school land would see many environmental losses. We have 2 deer who live on that land as well as several pheasant and a bird of prey (type unknown). The purpose of greenbelt land is to assist in safeguarding the countryside from encroachment, your proposals would not only encroach this beautiful piece of countryside, but it would completely destroy it and the habitat it provides for the wildlife described. Planning permission on this site has been refused, on several occasions, because of parish boundaries, wards and greenbelt, and I cannot see what has changed, apart from the pressure on the council to provide more housing. This is an easy win for the council in terms of finding areas for housing, which would seem to be affecting their judgement which has been applied in selecting this site as the detriment of the greenbelt land and safe environmental habitat for several species of wildlife.
