No indication at all here.

In general the plan itself is very poorly thought out regards the sites of the new builds, you have prioritised building on green playing fields and car parks, where are the residents and vast numbers of commuters going to park?

If the proposed housing development in Theydon is really to be limited to under 60 houses what is to become of the ground beside the station? Currently it is undeveloped and barely used except for illegal cars and huge quantities of litter? Will an open space replace this? Will it be rewilded and improve biodiversity?
