Draft Policy P 3 / Para 5.69

Of the Residential sites specified we have the following reservations - SR-0219 and SR-0541- Fire Station and Community Centre: we do not support demolishing two important community assets SR-0381 - Darby Drive - we do not support this development as it is on a site of historical importance and would spoil the skyline of the Abbey Gardens which is one of Waltham Abbey's most beautiful features; it will also remove some valuable car-parking space. SR-0903 - Swimming Pool - we wonder why as few as 27 homes are proposed for this site.
