My eldest daughter has to be driven toRedacted.... to attend the primary school as there are already not enough places in Epping. I understand the need for new housing but building on the hospital site (SR-055) would mean having to go to Harlow or beyond for appointments. Building on the sports centre site (SR-0347) removes the only sports facility from Epping. Building on the (already full) car park sites (SR-0348 and SR-0349) means parking will become a bigger problem. From the plan it looks like you are considering the tube station car park for development as well (SR-0229). There are already issues with commuters parking all over the place as this car park is usually full by 7am.
