8. An Interim Sustainability Appraisal has been commissioned to support the Draft Local Plan. We would welcome any comments you may have on this.

Big problems already with the tube station during rush hour - far too many people use the station and surrounding roads get gridlocked at busy times. We have commuters coming from outside the area already and parking all over the village as it is. How we could / would cope with even more commuters is not covered and I don't think has even been thought about. And I don't understand how on one hand the appraisal appears to indicate that the most high value green belt sites would be protected and then it says somewhere else that high quality green belt land will be lost. Which is it? I understand that Case Law says that just to create more houses isn't a special circumstance to develop on green belt land, so all of our clear and defensible green belt boundaries should be kept.

9. Do you wish to comment on any other policies in the Draft Local Plan?

On a separate note, extensions are getting larger and larger, disproportionately so, and there seem to be no discernible policies for the green belt on this. This also is having a detrimental effect on the village. We need a consistent approach on policies for the design and infrastructure of our area to ensure that Theydon Bois doesn't become just another over-developed that has lost all its character. And it doesn't appear that anyone
